2. Nomination papers must be delivered to the Returning Officer, Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN on any day after the date of this notice but no later than 4 pm on Thursday, 9th April 2015.
3. If any election is contested the poll will take place on Thursday, 7th May 2015.
4. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Tuesday, 21st April 2015.
5. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Tuesday, 28th April 2015.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Tuesday, 28th April 2015, must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Thursday, 7th May 2015.
